"An Ode To Teeth Gone By"

As I sit down to write this editorial, I am mourning the loss of my top teeth. I had all my remaining top teeth extracted at the end of February as a preliminary move, to move to a full top denture. For the past ten to twelve years my Dentist has been waging a battle to try and keep my teeth for as long as possible. Ultimately one has to decide if one is going to throw good money after bad, or make the tough decision and move to an alternate path.

I have been investigating options for teeth replacement. I had a consultation with a Regina surgeon who provided me with a quote for implant dentures to eventually replace my entire set of teeth. These implant dentures are the cat's meow. The problem is that the quote came to \$63,000. Ouch! It is no wonder that people have begun travelling to different countries for major dental work. The same item in a Cancun dental clinic was estimated to cost in the \$18,000 - \$23,000 range, plus the cost of four or five trips to Mexico.

So what do my dental woes have to do with municipal administration? I am using my dental situation to segue to a discussion about asset management in the world of huge infrastructure deficits. I will use the new arena construction in Wynyard as a comparison.

Although the old arena in Wynyard, now demolished, was older than my teeth, they both had similar trajectories. The old arena was constructed in 1950 and was in use to the end of the 2018-2019 arena season. My teeth were constructed in the mid-1960's and lasted until 2022. The old arena finally succumbed to age while my teeth were seriously affected by a medical condition. Both "assets" underwent a lot of maintenance to extend their useful lives; however, both assets needed full replacement.

The next decision to be made is how and what do you do to replace the asset. One does not need the "Cadillac" model; however, one also wants to avoid the Ford Pinto. For those too young to get the reference, in his book "Unsafe at Any Speed", Consumer Advocate Ralph Nader called the Ford Pinto the most dangerous car as its gas tank tended to explode even in minor collisions.

In my case, I had the option to go Cadillac on the top plate at a cost of about \$30,000 or do a regular denture plate, with extractions, at a more reasonable cost of \$3,700. When it comes time to replace my bottom teeth I will be looking at something more than regular dentures but less than an implant denture. The cost difference, in today's dollars, is \$33,000 versus about \$8,000 - \$9,000.

In the Wynyard Arena situation, a decision was made to build a facility for the next 70 – 100 years. The old wood-arch structure lasted 69 years and the thinking was a modern, steel constructed facility will last much longer. Although the facility is not a Cadillac, in my humble opinion, it is definitely a Jeep Grand Cherokee. As the cost of the facility went 20% over the estimated budget of about \$10,000,000 to \$12,000,000, the lack of a comprehensive asset management plan reared its ugly head. The Town of Wynyard undertook financing for about two-thirds of the costs. Interest and principal payments of about \$525,000 per year are really affecting our budget process. In addition, we burned through a lot of our reserves to pay for the other third of the project.

The moral of the story is that a municipality ignores asset management at their own peril. Asset management has been a hot-topic item for a number of years. I took the three-day course about ten years ago. The biggest thing I learned is that CAO's do not have time to properly implement an Asset Management Plan on their own. Municipal Councils need to be educated on the importance of asset management and have to be willing to commit the resources to get those plans implemented.

As I sit hear finishing up my editorial and thinking about my teeth, I am reminded of a clip from the movie "The Blues Brothers". Charles Napier's character says to the John Belushi character; "Well, suppose we ain't got no union cards and go in there and start playin' anyway? Whatcha gonna do about that? You gonna stop us, Stein? You're gonna look pretty funny trying to eat corn on the cob with no !@#\$%&* teeth!"

In closing, I want to wish everyone a warm and healthy Spring. I hope to see everyone at the UMAAS Convention in June.
